Natural Resource management program

SWERA since its inception has concerns for management of natural resources. Agriculture and animal husbandry, the most important means of livelihood sustenance in SWERA's Area engagement have witnessed constant falls due to perpetual draughts over the years. Moreover .rich ARAVALI hills of region are also losing their luster due to blatant plundering of its natural resources leading decreasing bio- diversity many of the medicinal plants.

In previous days SWERA played a vital role in managing this resource base through its pioneering interventions like construction of watersheds, well deepening farm bounding, forestation and pasture land development BADI development construction of water harvesting structures, horticulture, and so on moreover village forest committees were also formed to ensure people, s participation and sustenance of work done.

Through, in contemporary days SWERA has not been taking up any of those construction works due to funding constrains yet is engaged in promoting biodiversity by planting medicinal and other disappeared species of plants, strengthening village forest committees to better care of its earlier operations. Besides.

1. Summary

SWERA SANSTHAN has started the project "Socio Economic Development through promoting Quality Goat rearing as viable livelihood option for poor women in Ajmer district of Rajasthan". Proposal has demonstrates possibilities of enhancing livelihood opportunities by through village/ panchyat level community institutions and interventions in goat rearing. Project aims to reach 500-600 families belonging to poorer and excluded backward communities in 3 year.

About 10 villages of Srinagar and Silora block in Ajmer district are proposed to be covered under the project. The three type of interventions to be adopting in process:

- A. Goat Development
- B. MNREGA Awareness Program
- C. Farm and Fodder Development
- d. Tree Plantation

SWERA SANSTHAN applies its wider strategic aims and best practices to its development approach in Project Area. This is achieved through building the capacity of communities, strengthening systems of service delivery and undertaking operational research to develop, share, scale up and advocate for best policy and practice changes. The approach also ensures that the project components of Goat health, Maintenance, MNREGA Awareness, livelihoods and community empowerment work to re-enforce each other for integrated development.

2. Background of the project

The SWERA addresses the key constraints to Goat rearer community development by taking an integrated and holistic approach. The specific objectives are:

- Enhancement of poor Goat Rearer's income through breed improvement, improved management, feeding and sanitation.
- 2. Establishment of financially self sustainable training cum demonstration center for providing hands on training on improved goat rearing management for increased profitability.
- Building people's institution in the district to take up promotion of backward and forward linkages for goat rearing as reliable livelihood option by poor families.

- 4. Promotion of integrated environmentally sustainable model of goat rearing to be replicated by rural poor.
- 5. Creation of fodder developed cluster through people and SHGs a heading intervention as fodder development program.
- 6. Reducing drudgery and burden in the business and making available nutritious goat milk to poorer set of families as nutritional supplement for mother and child.
- 7. Effective implementation of NREGA and other relevant schemes of PRIs which through community participation and awareness creation.

Goat Trust, Lucknow is supporting the SWERA to provide technical support for the capacity building component of the project.

3. Program Finding

Fulfillment of objectives

The project targets poor and small ruminants for better goat production and market linkages, poor goat rearer women for increase livelihood opportunities and local political involvement.

Project Design and Implementation

Goal

Socio Economic Development through promoting Quality Goat rearing as viable livelihood option for poor women in Ajmer district of Rajasthan.

Specific Objectives

- Enhancement of poor Goat Rearer's income through breed improvement, improved management, feeding and sanitation.
- Establishment of financially self sustainable training cum demonstration center for providing hands on training on improved goat rearing management for increased profitability.
- Building people's institution in the district to take up promotion of backward and forward linkages for goat rearing as reliable livelihood option by poor families.
- Promotion of integrated environmentally sustainable model of goat rearing to be replicated by rural poor.
- Creation of fodder developed cluster through people and SHGs a heading intervention as fodder development programme.
- Reducing drudgery and burden in the business and making available nutritious goat milk to poorer set of families as nutritional supplement for mother and child.
- Effective implementation of NREGA and other relevant schemes of PRIs which through community participation and awareness creation.

The SWERA SANSTHAN has involved setting up the systems and processes to manage the project data collection and need assessment and to begin building relationships with different village institutions. SWERA SNSTHAN also established a partnership with Govt. Dept. to better effectiveness of program. We have categorized the report in four section of project.

1. Goat Development

Orientation Program to staff and other stakeholders

Different types of orientation program have conducted to better understanding of project to staff as well as other stakeholders. One day meetings held with Govt. veterinary functionaries to introduce the program in the area as well as Dist level.

Induction of Buck, Female Goat and its maintenance:

In this project during year we identified 120 families as project guideline and base line survey. We selected poor families and beneficiaries by the systematic and criteria as we set up in the project. In this year we selected 120 families which poor and goat rearing families. We contacted them and discussed them in the SHG/GRG's meetings. We motivated them about Sirohi breed of goat. We also discussed to purchase the female goat on the contribution basis. We told them that 1750rs we will give you from Revolving Fund for per goat. When the cost increased from fixed coast, people contributed by their level.

About the Buck of Sirohi breed were also purchased under this project. In this year GRG's members also purchased six bucks. We discussed about buck that "we providing these bucks to you for increase the pure breed of Sirohi". Here are the 6 units of Bucks which purchased by the common decision GRG.

These groups nominated a person from their GRG to maintenance and care of Buck. The groups decide the rates of service at 50-100 /Time which manage by selected person. The feeding cost also provided to this person and also supervises by project staff timely.

Out Put:

Breed Improvement:

We have also targeted on kids who birth by buck which have given in project area villages. We compare the impact of kids who births in this year. We compare other kids which birth by another buck. Comparatively we have found GRG's goats kids much better than other kids. In the below here are the numbers of kids which birth from project area bucks.

Training of Pashu Sakhi:

In this project year we have organized pashu sakhi three days residential training in SWERA Sansthan, Kanpura. In this training Dr. Paula and Mrs. Reena were as the resource person.

2. Fodder development

Establishing nurseries and plantation and its maintenance

As per planned in proposal in this year SWERA has planted 19745 fodder trees in the project area villages. These fodder trees planted in goat rearers field which merged with GRG. To establish and sustain a better management and production of fodder, nurseries have developed at GRG level. Beneficiaries has identified and selected from 10 villages who had some water resources and interested. SWERA has planted Neem, Nimbu, Amrood, Awala, Ber, Karund, Gunda, Ardu, shisham, babool, etc, in project area villages. These plants planted in monsoon season. Planted fodder trees in GRG's members were also maintenance by the SWERA 12320 plants. It has ensured to people to survive the plants through better management. In this maintenance we gave some knowledge about planting trees. We support them to planted trees in the field told them about sustainability the trees which you put their fields and use the "kala dana" for harmful insects.

3. M-NREGA Awareness/Follow-up

Training of Women leaders on CBO promotion and management:

As per planned in proposal we organized a training of women leaders on CBO promotion and management for two days in SWERA Sansthan, Kanpura. In this training GRG/SHG's members of 10 villages of project area were participated. It was residentially training. In the training we discussed on the MNREGA problems, management of CBO, acknowledge of MNREGA Schemes which started by Government, use of labor rights, etc.

Members learnt about CBO management, MNREGA Schemes and their rights.

Training of Women leaders on leadership development:

In this leadership development training SHG/GRG's members for lead the women issues at village level were participated. This training was organized by SWERA as per proposal in this year in Kanpura for two days. In this training the BDO and PO MNREGA Shrinagar also participated in the training. During the training we discussed about different type of issues as SHG/GRG management and leadership, legal rights and its awareness of women, participation in common decision of village etc. We also discussed about the role of women leader and role of other members in their groups. Learn them about unity and time. Participation is the most important thing in yours groups. Increase your capacity for protest their rights and role of leadership.

SHG Formation/ Strengthening:

SWERA Sansthan has organized for SHG strengthening programme. This strengthening programme organized in 10 villages of project area, In this programme SHG/GRG's members which 25 to 30 numbers were participated. This SHG strengthening programme also organized in SWERA Sansthan office, Kanpura. It was three days residential training which dated 28 members were participated in this residential training.

Cause of this SHG/GRG's strengthening programme to build their capacity to run their groups easily, unity amongst them, to sustain their financial problem, to know important and uses of rules and to use of breeding buck to get pure breed of Sirohi, insurance their goats and buck, management of goats and plantation of trees.

In strengthening programme of SHG/GRG they learnt capacity building and make group stronger, sustain finance in groups, breeding buck use, and management of plantation and goats.

Agriculture Dept participated as the trainer. He told about the advantages of plantation for animals. He also told how to plant the trees in the fields.

Improved Farming

Selection of Farmers, Goat Rearers and GRG Members

In 10 villages of project area, this year farmers have identified to undertake the various interventions such as Nursery set-up, water resource developments. A list of farmers have generated to further actions of water resource development and Nursery set-up and planting. To undertake these activities, workplace has also identified and discuss to further actions.

Agriculture crop-trail and demonstration

The crop trials have implemented during monsoon season in this year. Under this intervention, SWERA has selected the famers which have small piece of land and water irrigation facilities. Before trails, soil and mineral testing have undertaken during Agriculture Fair which was organized by Agriculture Dept. As per report, we have introduced the supplements of minerals. We distributed "Ravi and Kharif" crops seeds in this year. The three types of seeds Guar, Cahna, Moong, Ground-nut, Bhndi, Payaj, Ghobhi, Gehu, Rajka, Makka, have grown by the farmers. The farmers has also monitored and guided to timely cultivation and treatment. Through this intervention, according to Bigha the production has increased.

Water resource development

Through a brief discussion with the farmers, SWERA has decided and selected of five progressive farmers in the area for set-up the well recharging structure. These well recharged for farmers for their fields and increase their productivity. Through these structures, the water increased in the well and also demonstrated to people.

2 .Education & Gendar Programme

Ensuring Girl Child's Right in Ajmer Rajasthan State Main Objective:

The project is making continuous efforts to contribute towards the realization of basic education of children with focus on girls (MDG 2), promotion of gender equality and the

rights of women (MDG 3) and improvement of health of mothers (MDG 5) in the districts of Ajmer in Rajasthan, India.

The project is been implemented by organizations SWERA in 10villages Shrinagar block in Ajmer district in Rajasthan respectively to achieve the following objectives:

Approx. 313 SWERA and approx. 515 SWERA benefitted through the project through activities related to basic education of girls, promotion of gender equality and women rights and basic campaigns, rallies etc.



Single Objectives:

Assessment

The project has completed two years and achievements against the indicators are as follows

SO 1: Women actively participate in planning and implementation of activities for the improvement of the concrete living situation of women and girls as well as in Lobby

activities for the enforcement of Women's Rights on local and regional level.

Indicator SO 1:

At least 40% of the trained women community council members and at least 60% of the total SHG members are able to work effectively to reduce child marriages by the end of the project period

Indicator SO1: Government Health Services are being monitored by the SHG and VHSC members and at least 12 health centers are functioning effectively due to discussions at the community meetings

Indicator SO 1: Quarterly network meetings are organized and child marriage cases are stopped / case filed

The definition of helping their female counterparts at household work is relative person to person from helping to fetch water to even just picking up a glass of water as there are no parameters built on this.

A State level network meeting was held at Jaipur on 11th June where various NGOs participated on Ecological Rights of Youth. 30 youth from various NGO participated and were sensitized on Environment issues, Ecological Rights and role of Youth in Environment protection. The youth were then elected for the Youth Convention for Ecological Rights in Banglore.

1.5.1 Rajasthan Youth Network Workshops Input:

A state level youth Network workshop was conducted SWERA and Matasya Mewar at Jaipur where approx. 30 children and other NGO staff and Tdh staff participated. The workshop was mainly to sensitized youth from different areas about their Ecological Rights and their roles and responsibilities. The Resource person Mr. Dharmendra Chaturvedi from CUTS, Jaipur sensitized the children on current status of environment and threats related to the same, he also mentioned about various Government schemes related to Environment and Environment Rights.

One adolescent girls group and 1 boys group formed in every village, thus 20 girls group (Kishori Dal) and 20 boys group (Kishor Dal) formed in the project area, 198 girls and 200 boys of SWERA

Health programme:

As mentioned earlier without adopting a holistic approach of development making differences in lives of rural masses is a pathetic job. In this string SWERA started Working in the area of health with the objective of providing primary health care services

to rural masses. Initially,

the program concentrated on sanitation and health education issues but over the year's preponderance of our experiences suggested that maternal and child health is still an untouched issue Which requires more intensive efforts to keep the spiraling IMR &

priority stratum of organizations heal

MMR under check, thus the captioned issue was included and placed at upper mos

out to the target village communities thought a health center erected with the

hand holding support of population foundation of India and through a network of village health committees. This committee comprises of village health workers, traditional birth Attendants and a few members of women health groups. It was observed that while the program had been quite successful in terms of creating awareness about hygiene and health issues but need to focus on the problem of malnourishment among children and tuberculosis with more dedication. In case of our work on maternal and child health we had been more successful through creating and enabling environment towards institutional deliveries in the village.

TAG Officer Training Programme-

Organization under the TAG officer training programme held with the financial and technical support of Government of India and ARAVALI Jaipur, In this programme project target group are Secretary, LDC and Gram Sevak of the



and Pali districts of Rajasthan. The objective of the Government of India under "Pradhan Mantri Awas Yojana- Grameen (PMAY-G)" scheme to timely construct the house, tagging on time through "AWAS" mobile application, funds released on time to the beneficiaries and the Gram Panchayats could also provide land to the landless families. Under this training program SWERA Sansthan organized training programe at block level with the coordination of district Panchayati Raj Department.

SUMA (Surakshit Matratv Abhiyan) Project -

In Rajasthan the Maternal Mortality Rate has shown very slow decline and remains at an estimated 318 per 100,000 live births and the Infant Mortality Rate

at 59 per 1000 live births. (SRS, 2011).
Under-nutrition

contribute

s significantly to the high maternal and neonatal mortality rates. While efforts are being made for reduction of maternal and newborn mortality, there is still a



need to ensure accountability of the health system towards the citizens, particularly women and girls from disadvantaged sections. SWERA, proposes to create accountability mechanisms and health rights advocacy for effective implementation of Maternal Nutrition and Health services in Shrinagar block of Ajmer district, Rajasthan.

Objectives of the projects-

- To analyze, the gaps in health facilities in Shrinagar block of Ajmer district and to empower the community served by creating awareness on maternal health entitlements, and enabling them to raise their voices to ensure service delivery and enhance accountability.—
- To improve services provided on the Village Health and Nutrition Days(VHND)
- To organize women's group meeting like public hearings with the ICDS and health department staff for action on maternal health.
- A two pronged strategy will be adopted. One envisages on empowering communities to
 effectively access their entitlements and the second to facilitate a process of interactive
 dialogue between the citizens and the duty bearers at the village and block level. The
 project will use social accountability for effective implementation of services and
 schemes.
- To increase the demand for quality of maternal health services.

- To increase the access to and influence policy on maternal health services for marginalized communities at local and block level.
- To organize participation of marginalized women in advocacy activities for access to quality health services.

SWERA Sansthan directly connected with 1000 women's through Self Help Groups (SHG,s) from last 15 years so that easy to find lactating and pregnant ladies & implement this project effectively at local level and better coordination with govt. department.

Vitamin A:

SWERA Sansthan was implemented a more health programme with objective of reduce the Anemia in child, lactating & pregnant ladies with the support of a US organization "Vitamin Angels". Under this project SWERA Sansthan distributed and insures the use of Folic Acid tablet for lactating & pregnant and Vitamin A & Albendazol to 0

to 5 year age children of Srinagar block. For the sustainability of this project to regular interact with Aanganwadi Worker, ASHA sahyogini, ANM and also with doctor at primary health center.

Vitamin Angels provides life-changing vitamins to mothers and children under five who are at high risk of malnutrition due to food availability issues. By providing vitamin supplements to these vulnerable populations, Vitamin Angels is effectively reducing anemia, preventable illness, blindness, and even death – to create a healthier world.

Field Clinic: served the health needs of those who are not in a position of availing institutional health services in time due to their remote location.

Covid-19 Relief work -

The SWERA started the covid-19 relief project after the announcement of the 21day lockdown to provide food support to three hundreds families, who might have lost out on employment in this time of crisis. With the aim to raise local donation, should last a family of five for a week and contains a combination of basic staples such as wheat flour, rice and two kinds of pulses and some sanitation materials with following proper social distancing guidelines. Also distributed mask, sanitizer. Sodium chloride Sprinkled in village and public place. The organization has partnered with local donor and enterprises working on the ground.

- Artificial jewelry making Training: SWERA in collaboration with Indian military; Nasirabad Cant organized 25 days long Artificial jewelry making Training, mainly for dependent of ex military men under its AWWA (Army wife welfare association) initiative . Training was organized at Ajmer and total 22 women participated in it. These women developed their making Artificial jewelry set using easily available material in a cost effective manner.
- 2. Stitching training: NYK Aimer stitching balad ka dara , Tikayada, A 45 days long stitching training was organized in association with Indian military; Nasirabaad Cant and Gas Authority of India Ltd .(GAIL) . A total of 45 days Women (mainly from different SHG Working Groups) attended it and developed/polished their skills in stitching cloths and embroidery work. Training was organized at training centre, village-Kanpura resource person, tailoring machines and other

necessary equipments were provided by GAIL. Now organization is now trying to arrange a shop in Ajmer to sell the materiel produced by women.

- **3. BAL MELA :-** like wise previous years SWERA once again organized two days long "BAL MELA " for children different competition viz essay writing, drawing Competition, sports Competitions took place during the events winners conferred with prizes to keep their motivation level high. The programme ended with a puppet show conveying the message of avoiding quacks performed by "Sanchar Teem" of SWRC-Tilonia.
- **4. Model kitchen** :-visualizing the catastrophic climates changes bound to happen 15-20 year later due to plant plundering of natural resource; especially forests organization is promoting use LPG with the ultimate objective of keeping a tub on unwise cutting of trees (to be used as fuel for cooking) and to make cooking pollution free and rather safer from health perspective .SWERA in previous year has already setup model kitchen centers in different village to teach people using LPG and to demonstrate the use of different time and power saving utensils (pressure cooker ,oven and soon) which are still widely unused in rural areas. These centers are looked after by our village level institutions viz. working groups SHG etc. and cylinders are filled by community contribution.

Future plan; in reface to the perspective plan of SWERA the organization in days to come to come is days to come is all set to speed up its endeavors in the area of Livelihood development, natural resource management, labor welfare through the entitlement of govt. schemes and health "much rigorously. SWERA also believes that imaging development without resorting to a holistic approach is a strenuous task hence: it has incorporated varied dimensions of development (To be handled much intensively) in its plans for forthcoming days. Future courses of action would be as follow.

In the area of natural resource management, organization will continue its ongoing endeavors with increased intensity. Once again, mainstay of its interventions would remain "promotion to bio diversity"

While taking about "children's development "SWERA will be rigorously indulged in promoting "children rights" especially "child participation.
