## Background

"Social Work and Environment for Rural Advancement" (SWERA) is a non-profit, non-political & secular organization founded by a group of youths. Initially, the group worked as a cultural team, spreading the awareness towards Education, Health, Natural Resources Management and Livelihood opportunities in the blocks of Shrinagar, Silora and Arai of Ajmer district. In order to extend the services more effectively, the group finally decided to register itself in State authority concerned. It was registered under Rajasthan Society's Registration Act, 1958/28 under Registration No. 54 on 2<sup>nd</sup> December 1995.

## **ABOUT SWERA**

SWERA firmly believes that development exist and sustains through community participation. It is what the organization stands on and does till today. From the very beginning organisation has been continuously working for integrated rural development in the areas of Natural Resource Management, Women empowerment, Reproductive and Child Health, Education of rural children and Micro-finance & Micro credit.

SWERA (Social Work & Environment for Rural Advancement), was instituted in 1995. SWERA has been facilitating social sector activities to raise awareness and work on various socio-economic issues. The combat area of SWERA was initially restricted to the Ajmer district only, but lately, SWERA has been active in other districts of Rajasthan, like Nagaur, etc. SWERA has identified Health, Education, Livestock raising and Enterprise training, Natural Resource Management and Women Empowerment through livelihood development as its major thrust areas and has been working continuously on the same through its village-level institutions.

- 2. Before any initiation, the basic data of the location or stake holder is collected for preliminary understanding and analysis. Post which gram sabha is organized to interact with all concerned stake holders about the proposed activity for transparency, credibility and accountability to ensure that the ownership is taken by the concerned stakeholders in view of the program sustenance.
- Activities such as puppet show, and street plays are conducted to sensitize the public at large
- 4. With reference to the objectives of a particular program/activity staff of SWERA are oriented to understand the expectations from the program. Later, head line, log framework analysis, review with the indicators, periodical reviews and feedback mechanisms are the various steps in assessing and improving the quality of the program
- 5. Primarily focused Qualitative approach: non-quantifiable information prevalent trends in thoughts and opinions.
- 6. Interview guidelines: an unstructured interview with open ended questions to gather better in-depth and descriptive responses of information related to the topic
- 7. Data Collection: face-to-face interview, FGDs and interaction in villages.
- 8. Data Analysis: Analysis of the collected data through interpretation and analysis.

### **STEPS TOWARDS SUSTENANCE**

SWERA has been emphasizing on empowering the community groups in view of program sustenance. In this regard, the following are few illustrations to exhibit the empowerment process.

## 1. PRERNA DAL (Adolescent Girls Inspiration Group)

The Prerna Dal will be play a major role in various type of issue related to Girl's health, education & child marriages etc. The groups to be obtained quality education and subject focus teaching at the center. They will manage all kind of activities which implement through the Girl Resource center at village level. They will attend the monthly meeting and share the ideas about problem and solution on girl child's matters. Basically it would be platform for discuss on any issues to girl children. Prerna Dal members will organize meeting at monthly basis and discuss on various lacuna and obstacles which are facing by them.

## 2. Adolescent Boys Groups

The groups of boys will represent their view on various gender discrimination related issues. To be create the atmosphere for gender balance by these Boys groups. They will play a resource at domestic level for support the gender equity. The each member of groups will facilitate and motivate to twenty families and another boys to mitigate the son preferences problems.

## 3. Child Right and gender committee

This committee will lead all kind of gender discrimination awareness programme. The committees would supervise to implement the rules of Right to Education Act and Child Right Policy in the existing schools of villages. The organization will facilitate to them for effective implementation plan of concern act. About the rules and policies would by taught by the organization. Any practices which influences to the issue would be coverage by the C&GC and report to concern authority.

## 4. Village level Executive Committee

The executive committee would construct from the 13 members. The members of committee would be key person of different village level committees/association/groups such as SDMC, SHGs, Prerna Dal, Gender and Child

Right committee, Traditional Panchyats, Women PRI Leaders. The executive committee will act as a support agency cum pressure groups to take interventions such as awareness programme, coordination with PRIs etc. All kind of decision by SDMC, PHC, and ICDS will be keep supervision by these committees and take an action accordingly. Monthly review will be done during the visit to various village level institutions such as Aganwari Center, PHC, Schools, and PHED etc.

## 5. Village Health and Sanitation Committee

Village health committees would facilitates and motivate to women for household and village cleanliness. The actions of the village health functionaries would be supervise by the committees. This committee will monitor and address the lacuna between Govt. health systems at village level and do needful actions. The basic amenities related to health such as medicines, infrastructure, equipments, tools at the govt. Health sub center, PHC, and CHC would be ensure by the committee. Also as an action to fill the lacuna to be contact to Govt. Health authorities.

## 6. Women' Groups/SHGs

The women Groups will act as a pressure groups on various stakeholders of Project. Also they would lead and as well as participate during all kind of campaign on women or girl's education and VAW related issues in villages. The follow-up and supervision of various Govt. Schemes would be undertaken in the village by the groups. These group would be also undertaken the various income generating activities who promote their livelihood status as well as sound at economic sphere.

## 7. Theatre team (Chaka-Chak Toli)

To easily communicate of communities in local language, the one theatre committee would be form at whole project area which will play different dissemination role about different aspects of project. The members of theatre team would be identifying from Child Right and Gender Committee which have potential of presentation skills. This team will display through different ways such as puppet shows, Nukkad Natak, street play, song presentation etc. The theatre team will be creating an environment about various gender issues and practices as child marriages, VAW, Girls education, gender equity. The all kind of facilitation support will be providing by the village Executive Committees and SWERA.

## MONITORING, SUPERVISION, AND REPORTING

Objectively verifiable and measurable monitoring indicators on process, output and outcomes will be established and will be collected, analyzed, and documented on a regular basis. The project will be jointly supervised by supporting agency (Donor), SWERA as well as Village Executive Committees on a regular basis (One time In a year or as required) will be encouraged to provide TA to help implement and monitor project activities and to contribute to the various assessments and reviews that will be conducted during the life of the project. The scope of audit will include technical and fiduciary processes and their adherence to the project guidelines. In addition, as noted above, the project would experiment with community level monitoring of progress such as internal review at the basis of such intervals. The following reports would be produced and used for monitoring each of the two components: Quarterly project implementation; Monitoring and financial reports; supervision reports

#### **MAJOR PROGRAMMES**

#### 1) Natural Resource Management Program (NRM)

SWERA, since its inception has concerns for Management of Natural Resources. Agriculture and animal husbandry, the most important means of livelihood sustenance in SWERA area of engagement have witnessed constant falls due to perpetual draughts over the yrs. In previous days SWERA played a vital role in managing this resource base through its pioneering interventions like construction of Watersheds, well deepening, Farm Bunding, Forestation and pasture land development, Baadi

Farmer Field School (Goatry)

Furthermore, working on an entirely new initiative, the organization this year organized Farmers Field School (FFS) in village Navav and Balad ka dada under strategic name "Family Livelihood Resource Center" (FLRC). Core objective of FFS was to facilitate people's livelihoods through goat promotion which has now established as principle livelihoods support strategy in such arid parts of Rajasthan. Farmers groups were trained on management of goats like their breed improvement, their health, livestock insurance etc. Results of FFS in captioned villages were quite encouraging. Fairly a large number of people adopted Goat rearing as supplementary livelihoods option. People were also linked with different welfare/ empowering schemes.

Rain Water Harvesting Program

- The rain water harvesting program was taken up by SWERA in June 2005 and was supported by CAPART. Main focus of this program was Preservation of rain water, Proper and meaningful usages of rainwater, Environmental education to the rural masses, Improvement in agriculture techniques and adaptation to changing techniques.
- Science & Technology Centre
- Moreover, "Department of Science and Technology, Ajmer" also played a pivotal role in upgrading people's existing skills base through different training programs and enabled them to earn food security to their families by exercising these newly learnt skills. Trainings on "House Making, Diesel Engine repairing and Scientific Advancement of Agriculture was organized with hand holding support of DST, Ajmer.

## 2) COMBATING POVERTY PROJECT

Combating poverty through Child development program envisages catering to educational needs of the deprived children with special focus on the girl children apart from promoting child rights. Apart from this organization has a thinking to work voraciously on institution building by educating deprived, forming groups of women, adolescents groups and children so that they start recognizing their rights and demand their right givers this bottom –to –top approach was initiated by the organization under the strategic name "Combating Poverty" and it came into effect from the month of October 2005.

SWERA is putting a lot of effort to impart quality educational opportunities and better health care for children & women in 10 villages of Shrinagar block of Aimer District (for livelihood promotion). It is working on four components viz. Education, Health, and Women Empowerment and advocacy strategies with special focus on child, Women rights. The implementation is being carried out by community themselves, especially the-formed women's working groups in the villages. Other important part is time to time training and capacity building activities for staff members.

Major Activities: - Running NFE, Enriching Library, Strengthening children's Group (EPHC Committee), Theater Training, Wall News Paper, Training of Education Working Group

### 3) SSATHI PROJECT

To extend the outreach of its education program SWERA is also running two bridge course centers -making pioneer interventions to supplement SSA by streamlining SDMC committees in 22 villages under the strategic name "SARV SHIKSHA ABHIYAN & TRAINING HELP INNOVATE" Project. Lack of education is one of the root causes of all social problems and needs effective intervention as soon as possible. The non formal education program (SSATHI) is running since June 2005 in 22 villages of Shrinagar Block. To bring about change in community attitudes towards education an enrollment campaign and a rally were organized where 3536 children from 22 government schools participated in it. Furthermore, different awareness programs, conveying the importance of girl child education through folk media Viz. Street plays, puppet shows were organized which had far reaching implications. The organization also supplements the functioning of Sarv Shiksha Abhiyan therefore different trainings and workshops, disseminating the information about SSA were organized for School Development and Management Committee members, School teachers, anganwari workers and pachayat departments.

Major activities: - BCC Activities, Training on SSA, Opening up Bridge Course Centers

#### 4) Literacy to Livelihood Project

This Project apart from SSATHI "Literacy" (educating girl) and "Livelihood" (Providing them with different vocational trainings to open new avenues for strengthening their livelihoods). Dropped out girls were trained in stitching and solar Lamp making apart from educating into two batches at "Swawlamban Shala"

Major Activities: - Dropped Out Girl Mainstreaming & Vocational Training

#### 5) Health Programme

To sensitize the rural mass on health issues under the strategic name "Combating Poverty" women's groups (also known as working groups on health) were formed and educated on cure and prevention of different seasonal diseases, symptoms and prevention of malnourishment among children, importance of ANC, PNC and institutional deliveries, immunization and so on. Major activities: - promotion of institutional delivery by skilled Birth attendants, Checkup facilities, Field Clinic, VHW training, TBA training, TBA and ANM Collaboration, Adolescent group, Village Health Committee, Government Liaisoning, Networking & Convergence.

Adolescent Groups: adolescent are the most important section of the community and SWERA has involved them through constituting a village level group for them. Village Health Worker regularly organizes meeting of the groups. These groups disseminate health related issues to the community. The group is also oriented regarding sanitation, primary health, pregnancy process, child rights, gender sensitivity and importance of institutional delivery.

#### 6) RCHSMI Reproductive Child Health & Safe Motherhood Initiatives Project

In context of rural health the situation of maternal and child Health it is somewhat critical. Rural masses are still not able to avail the common health facilities. In Rajasthan the status of MMR & IMR is far behind in comparison with other states. The MMR of the Rajasthan is 640 per lacks live birth and the IMR is 70 per 1000 live birth. The reason behind this is lack of awareness in the rural areas about the safe delivery or the institutional delivery. They are still in the social incarnations. To come out from the old systems SWERA started an RCH Centre at the village Kanpura of Aimer District with the help of PFI New Delhi and technical support of ARTH Udaipur. The centre covers 20 villages and provides Health services to the people. After the establishment of the centre people have started availing facilities of delivery by the trained nurses. ANC, PNC checkups facilities are at their doorsteps. These are done by

our outreach activities like field clinic and Facility of Home Services/ Home delivery. Nominal fees are charged for institutional delivery and for medicines.

Major activities: - Field Clinics, Health Centre, Training of VHW, Assisting Govt. ANM in reaching out to people.

7) Livelihood Development Programme

PEHAL Project & Combating Poverty Project

In the recent past micro-finance has emerged as an effective tool in combating poverty and ensuring Sustainable Livelihood Development of people. The concept includes providing thrift, Credit and other financial services and products of very small amounts to the poor in rural, or semi urban areas for enabling them to raise their income levels and to improve their living standards. Sustainable livelihood development has been one of the major thrust areas of SWERA since its inception. Keeping it into consideration the organization started working in this area to meet the livelihood developmental needs to the area. The programme is intended to explore the means of income generation by formation Of Self Help Groups, providing those necessary inputs in terms of trainings, bank linkages and covering them under the umbrella of social security services. The project is quite different from other Self Help Group programmes running in diverse parts of the country as it follows the revenue Generation Model. The model talks of checking the spoon feeding tendency of organizations in regard of inputs to the groups. It focuses on managing SHGs affairs by themselves viz. regular group meetings, bearing administrative cost and receiving a very nominal service charge from groups for organization inputs to ensure their active participation in the entire developmental process. In the current year 39 New SHGs were formed with total member of 470. Total savings were around 7 lacks Rs. 23 new bank linkages were also done this year.

Major Activities: - SHG Formation, Record writing training, Bank linkage & Credit, Capacity Building

#### 8) Family livelihood Resource Centre Project

Apart from this the organization also came up with a new project to strengthen the livelihood needs of poor under the strategic name "Family Livelihood Resource Centre" under this project five hundred poorest families have been identified through PRA to work with and to lift them out of their poverty in a sustainable manner. In days to come these families will be

segmented into different groups on this basis of their inputs needs and then will be provided with different trainings, exposure etc. accordingly.

#### 9) Networking & Convergence

SWERA maintains amicable relationship with different government and non government organizations to create differences in existing socio-economic canvas of targeted communities. The organization is a member of core group of "District level Health Committee", "District and State level committees on National Rural Health Mission", and "District level committee on NRM and Child laborers". Moreover, it is also an integral part of "Monitoring and Evaluation committee on National Rural Employment Guarantee Act". Apart from those, the organization also maintains trustworthy relations with Indian Army, Nasirabaad Cant, Gas Authority of India Ltd. (GAIL), Krashi Vigyan Kendra - Ajmer, Department of Science and Technology, Jaipur. In local, the organization has good understanding with all the government departments and institutions viz. Panchayati Raj, department of education, Primary Health Centers of the Area and so on.

The organization constantly endeavors to enlarge its existing network by participating in different local/ state/ national level seminars/ workshops/ training programs and discussions. Such platforms keep it updated with policy level changes at national and international levels, strategic advancements in the sector and magnify its existing knowledge base to make remarkable differences in people's lives.

Apart from these programs SWERA has taken up different activities in collaboration with different NGOs and government departments throughout the year. These activities proved quite enriching in terms of exposure and capacity building of their participants and enabled some of them to add in their family income.

#### 2 Reducing incidence of Child Marriages

The people especially women will be sensitize for eradicate the child marriages and its bad results. After the project period the local functionary as well as govt. officials will be aware and active because of the pressure groups to be undertaking the protest against child marriages. The 60 % of child marriages to be reduce the project area.

3 **Proportion of girl children in leadership and Decision maker** in primary and secondary education the campaign to be start for enrolls the girl children in the elementary and secondary education school. The village contact drives tools such as household contact, rally, will be adopt for achieving the targets. After the awareness programme the people will be sensitize for girl children education and its importance. The 65% enrollment in govt. schools of girl children will be increased.

# 4. Build-up an identity of women at economic sphere through livelihood interventions.

To be ensuring better livelihood opportunities of 200 women through SHG and skill building programmes. These women would avail the better economic realm by income generation opportunities. The potentiality of Income Generating activities will be identified so that the women would get better returns of their products.


#### 5. Ensuring the effectiveness of Public delivery system.


